  - Prior experience in performing bridge inspections complying with 23 CFR 650, Subpart C, including the performance of Level I and Level II underwater inspections.
  - · Be financially stable.
  - · Have a local business license.
  - Have a current Certificate of Authorization approved by the PEALS Board.
  - Have personnel who meet the qualification requirements of 23 CFR 650.309.
  - · Be properly insured for the work to be performed.
