**NOTES FOR INVITATION FOR BID:**

- Sealed bids should be submitted in duplicate at the 2nd Floor, Division of Highways Building Room 201, Department of Public Works, 542 North Marine Corps Drive, Tamuning, Guam 96913, no later than 2:00 P.M., on the date specified above. At this time the bids will be publicly opened and read aloud to the public.
- Contract time is per the calendar days after the issuance of Notice to Proceed as specified above. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Accepted form of bid security may be bid bond, certified check or cashier's check payable to the Treasurer of Guam.
- The sureties of all bonds must be on the approved listing by the the United States Department of Treasury listed as "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and Acceptable Reassuring Companies". The penal amount of the bond shall not exceed the surety's underwriting limit as stated in the Department of Treasury listing. A notarized true copy of Certificate of Authority is also required.
- Please note that all Bid Documents and related Addenda can be obtained at the 2nd Floor, Division of Highways Building Room 201, Department of Public Works, 542 North Marine Corps Drive, Tamuning, Guam 96913. Submission of sealed bids will remain at the Department of Public Works.
