UNDER PAVEMENT INFRASTRUCTURE RETROFIT	GU-DAR-1000(113)	This is an improvement of Route 1 and Route 3 from Route 10A to Route 3 and from Route 1 to Route 28, having a total approximate roadway length of 28,658 feet (5.43 miles). The project includes construction of new pavement and vault covers to strengthen the pavement section for overweight and oversized vehicle convoys from Route 10A to Route 28 on Route 1 and Route 3. - The sureties of all bonds must be on the approved listing by the Government of Guam or United States

Department of Treasury list as "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and Acceptable Reassuring Companies". The penal amount of the bond shall not exceed the surety's underwriting limit as stated in the Department of the Treasury listing. A notarized true copy of Certificate of Authority is also required.
