Anticipate Full Road Closure for Reconstruction of Route
14B (Ypao Road) October 2022 through May 2023
(9/6/22)

Tamuning, Guam - The Department of Public Works announces that through its contractor, InfraTech International, LLC, a full road closure on Route 14B (Ypao Road) is required for the reconstruction of this main thoroughfare in Tamuning.

The full road closure is expected to commence October 2022 and continue through May 2023 between Congressman Palting Loop and Pale San Vitores Road. The overall project includes the reconstruction and widening of Route 14B (Ypao Road) from its intersection with Carmen Memorial Drive to the intersection of Route 14 (Pale San Vitores Road). The total project length is 0.35 miles. Improvements include but are not limited to – shared use of bicycle lanes, curbs, gutter, sidewalk, storm drainage system, retaining walls and utility relocations.

Road construction may affect businesses and residents along this roadway. Anticipate delays and plan your drive accordingly. The DPW thanks everyone for their patience as the agency improves the driveability and safety of this major roadway.

NOTES:

1. Sealed bids should be submitted to the Division of Highways Building, 2nd Floor, Room 201, Department of Public Works, 542 North Marine Corps Drive, Tamuning, Guam 96913, no later than 2:00 P.M. on December 1, 2022. At this time, the bids will be publicly opened and read aloud to the public.
2. Contract time is 240 calendar days after the issuance of Notice to Proceed. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Accepted forms of bid security may be bid bond, certified check or cashier's check payable to the Treasurer of Guam.
3. The sureties of all bonds must be on the approved listing by the Government of Guam or United States Department of Treasury list as "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and Acceptable Reassuring Companies". The penal amount of the bond shall not exceed the surety's underwriting limit, as stated in the Department of the Treasury listing. A copy of the notarized Certificate of Authority is also required.
4. Please note that all Bid Documents and related Addenda can be obtained at the Division of Highways Building, 2nd Floor, Room 201, Department of Public Works, 542 North Marine Corps Drive, Tamuning, Guam 96913. Sealed bid submissions will remain at the Department of Public Works.
