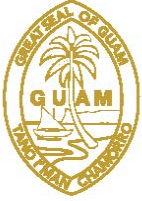

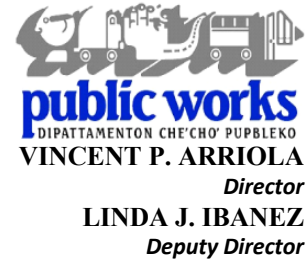

All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Accepted form of bid security may be bid bond, certified check or cashier's check payable to the Treasurer of Guam.
3. The sureties of all bonds must be on the approved listing by the Government of Guam or United States Department of Treasury list as "Companies Holding Certificates of Authority as Acceptable Sureties on Federal Bonds and Acceptable Reassuring Companies". The penal amount of the bond shall not exceed the surety's underwriting limit as stated in the Department of Treasury listing. A notarized true copy of Certificate of Authority is also required.

Groundbreaking Ceremony for Route 1 Resurfacing from Route 30 to Route 10A

(Tamuning, Guam, June 25, 2021) Please be advised that the Department of Public Works will be having a Ground Breaking Ceremony for the Route 1 Resurfacing from Route 30 to Route 10A.

Date: Tuesday, June 29, 2021

Time: 9:00 A.M.

Location: TuTuHa Park, Tamuning-Tumon-Harmon Mayors Office

Project: This project includes restoration of existing distressed/failed asphalt wearing surface along Route 1 Marine Corps Drive in the village of Tamuning. Approximately 1.58 miles of road will be resurfaced, from Route 1 at Route 30/Governor Carlos G. Camacho St. to Route 10A/Airport Road. Work includes milling and overlaying, full/partial depth repairs, replacement of utility manholes, repair of drainage inlets, and replacement of old sign panels and new striping. The \$7.2M project is funded by the U.S. Department of Transportation Federal Highway Administration. Completion of work required is within 300 calendar days from the Notice to Proceed (NTP).

Groundbreaking Ceremony for Route 1 Resurfacing from Route 30 to Route 10A

(Tamuning, Guam, June 29, 2021) The Guam Department of Public Works held a Groundbreaking Ceremony today for the Route 1 Resurfacing from Route 30 to Route 10A at the TaTuHa Park by the Tamuning Mayor's Office. The project is funded by the Federal Highway Administration and Hawaiian Rock Products is the contractor.

The project includes the restoration of the failed asphalt road surface along Route 1 Marine Corps Drive in the village of Tamuning. The road will be resurfaced, from Route 1 at Route 30/Governor Carlos G. Camacho St. to Route 10A/Airport Road. Work includes milling and overlaying, full/partial depth repairs, replacement of utility manholes, repair of drainage inlets, and replacement of old sign panels and new striping. The \$7.2M project is funded by the U.S. Department of Transportation Federal Highway Administration.

Vincent Arriola, Director of DPW, commented, "Although this project is primarily for resurfacing of a stretch of Route 1, work beneath the surface is required to ensure the stability and strength of the road especially with a traffic volume of over 33,000 vehicles on a daily basis. We're grateful for the partnership with Hawaiian Rock Products on this project."

Governor Lou Leon Guerrero stated, "The foundation of a safe and prosperous community includes adequate and properly maintained infrastructure. This exact stretch of roadway was last rehabilitated in 1996 and my pledge is to continue pursuing projects that have long been overlooked, especially when it comes to the safety of our people."

DPW estimates the work to be completed within 300 calendar days from the Notice to Proceed (NTP).
