# **REMINDER:** Closure of Route 14B (Ypao Road) for Installation of Street Lights (9/6/24)

The Department of Public Works (DPW) announces the road closure of Route 14B (Ypao Road) from Congressman Palting Loop to the Pale San Vitores Road intersection on Saturday, September 7 and Sunday, September 8, 2024 from 7:00 AM to 5:00 PM.

The penal amount of the bond shall not exceed the surety's underwriting limit as stated in the Department of Treasury listing. A notarized true copy of Certificate of Authority is also required.
